

PROMOTION TERMS

1. Participants agree to these terms (the 'Terms'). Any information or instructions published by TP Vision Europe B.V. ('TPV'), with its registered offices at Bernhardplein 200, 1097 JB, Amsterdam, The Netherlands or its fully owned subsidiaries about the Promotion (defined below) at <https://www.audio-cashback.com/philips/gb/en> form part of the Terms.

THE PROMOTION

2. Participants who subject to these Terms Participants resident in the UK or ROI who:

- (a) purchase a Qualifying TV from a Participating Retailer (both defined below) between 00:01 1 March 2022 and 23:59 30 May 2022;
- (b) Register the purchase of the Qualifying TV within 14 days (The date of purchase counts as day 1); and
- (c) either in the same transaction or within 30 days of the date of purchase of the Qualifying TV (date of purchase counts as day 1) purchases one or more Qualifying Audio Products (defined below) (maximum 1 (one) Soundbar and up to 2 (two) speakers) subject to the limits at condition 6) from any Participating Retailer;

ELIGIBILITY

4. The Promotion is only open to UK and ROI residents aged 18 or over ('Participant'), except:
 - (a) employees of TPV or its holding or subsidiary companies;
 - (b) employees of agents or suppliers of TPV or its holding or subsidiary companies, who are professionally connected with the Promotion or its administration; or
 - (c) members of the immediate families or households of (a) and (b) above.
5. Businesses are excluded from participating in this Promotion.
6. A claim must be made by the Participant, and must not be:
 - (a) submitted through agents, retailers, resellers;
 - (b) automatically generated by computer;
 - (c) completed by third parties or in bulk; or are
 - (d) illegible, have been altered, reconstructed, forged or tampered with.
7. Only a maximum of three (3) claims per Participant is permitted i.e. one (1) soundbar and up to two (2) speakers. Only one (1) claim for a Reward per Qualifying Audio Product is permitted. This Promotion cannot be used in conjunction with any other promotion.
8. Participants who return the Qualifying Audio Product to the Participating Retailer within thirty (30) calendar days of the date of purchase will not be eligible to receive the Reward. The date of purchase counts as day one (1).

ENTRY

9. To be eligible for a Reward each Qualifying Audio Product must be purchased within 30 days of the date of purchase of the Qualifying TV. The date of purchase counts as day 1 (one).
10. The purchase of the of the Qualifying TV must be registered at <https://www.audio-cashback.com/philips/gb/en> ('Website') within 14 days from the date of purchase. The date of purchase counts as day one (1).
11. Participants may only submit a claim for a Reward between thirty (30) and sixty (60) calendar days of the date of purchase of a Qualifying Audio Product.
12. Participants must complete and submit the claim form available at the Website. In order to complete the claim form, the Participant must provide the details requested, details of their UK or ROI bank account where the Reward shall be paid and upload a copy of their proof of purchase of the Qualifying TV and Qualifying Audio Product in the form of a receipt(s) or invoice(s) from the Participating Retailer. Complete claim form information and proof of purchase must be received on or before 23:59 on day 60 from the date of purchase of the relevant Qualifying Audio Product to be eligible to claim for a Reward. See FAQs on the Website for details of claim form information required and the form of supporting documents required as evidence of purchase from the Participating Retailers.
13. If the Qualifying Audio Products are purchased in separate transactions a claim must be submitted for each transaction.
14. The Reward is not negotiable or transferable.
15. The Qualifying Audio Products are subject to availability while stocks last.
16. The Administrator (defined below) will transfer the Reward within thirty (30) calendar days of successful claim validation, to the bank account provided by the Participant in the claim form.
17. If a claim is deemed not to have been submitted correctly, the Participant will be notified via email and offered the opportunity to provide the required information within seven (7) calendar days of receipt of the email. If no response is received within seven (7) calendar days of the email being sent, then the claim shall be marked as invalid and the Participant will no longer be eligible to receive the Reward. It is the Participant's responsibility to contact us if the Participant has not received an update on the status of the Participant's claim within seven (7) calendar days.
18. Subject to condition 17 above, claims that are incomplete will be deemed invalid. TPV or the Administrator are not responsible for lost, delayed or damaged data which occurs during any communication or transmission of claims.
19. TPV reserves the right to withdraw, suspend or amend the Promotion or these Terms to disqualify claims which it considers do not comply with these Terms at any time at its own discretion. TPV's decisions regarding all promotional matters will be final, and no correspondence will be entered into.

TPV and the Administrator shall have the right, where necessary, to undertake all such action as is reasonable to protect themselves against fraudulent or invalid claims including, without limitation, to generate or require further verification as to proof of purchase, as well as the identity, age, and other relevant details of a Participant, deny issuing the Reward, or terminate the Promotion due to the possibility fraud. This process may involve TPV sharing information with third parties.
