CURRYS £10 OFF VOUCHER CODE PROMOTION 2025 FOR ELECTRICAL RECYCLING

UK Terms and Conditions

1. **Promoter:** Currys Group Limited (Registered in England no. 504877), 1 Portal Way, London, W3 6RS.
2. **Eligibility:** This promotion is open to all UK residents aged 18 years or over ("Participants"). This excludes Isle of Man.
3. **Promotional Period:** The promotion is open from 11.06.25 until further notice. A redemption window will apply and be shown on the £10 voucher.
4. **Qualifying Product:** Any electrical product powered by a battery or mains supply via a plug. Working or non-working. Does not need to have been purchased from Currys.
5. **Products not returnable** – Unfortunately any items which are handed over to "service desk" for recycling will not be returnable. It is the customer's responsibility to back up and remove any personal data.
6. **Products that can be worth more than £10** – Value at least £10 refers to some products that can hold a trade-in value higher than £10 (based on condition). These products include mobile phones, laptops, tablets, smart watches and games consoles.
7. **Promotion Offer:** When you recycle a qualifying product at a "retail store" during the "Promotion Period", you will be rewarded with a £10 off voucher to be redeemed in-store or online. The voucher will be provided instantly in store when you recycle your old tech. A minimum spend of £50 applies on redemption. This offer is limited to one voucher per customer and not per the quantity of products recycled.
8. **Entry Instructions:** Bring in any electrical product to a Currys store to be entitled to £10 off your next eligible purchase when you spend a minimum of £50.
9. **Redemption:** There is a £50 minimum spend on redemption. Purchases made outside of the redemption window will not be accepted by the Promoter.
10. **Exclusions:** Unfortunately, the £10 off voucher cannot be redeemed on any Gift cards, Consoles, Apple iPads, AirPods, Apple Mac, Apple Watch or Mobile products.
11. **General:** The Promoter reserves the right to request such information as it considers reasonably necessary or desirable for the purpose of verifying the eligibility of validity of an entry and any gift may be withheld unless and until the Promoter is satisfied with the verification
