

Terms & Conditions

1. Subject to full compliance with these Terms and Conditions, an individual over the age of 18, who is a legal resident of the United Kingdom only (including the Channel Islands and Isle of Man) (Participant), and who between 00:01 (BST) on 30th October 2023 and 23:59 (GMT) on 29th February 2024 (Promotion Period) purchases a new (i.e. not second hand or refurbished) qualifying Lenovo Yoga notebook as listed in Table 1 below (Qualifying Product) from Currys or Lenovo.com (Participating Retailer) will be eligible to receive a free Inspire Travel Card worth £50.00 (Reward) and will be entered into a Prize Draw (Draw) with a chance to win a prize listed in Condition 3 below (Prize) when they visit the Promotion site shown in Condition 7 and complete the form in order to submit a Claim (as defined below) subject to full compliance with these Promotion Terms and Conditions. 2. Participants may purchase up to one Qualifying Product and claim up a maximum of one corresponding Reward, with a limit of one Reward per household.

5. This Promotion is not available to anyone professionally connected with this Promotion. You must enter directly as the Participant, without anyone else doing so on your behalf. No bulk entries. Entries from trade, consumer groups or third parties will not be accepted.

6. Participants must visit <https://lenovopromotions.com/yoga> and complete the presented online claim form, submit a copy of their proof of purchase (the Claim) and submit any requested contact information to be eligible to receive their Reward and be entered into one of the Prize Draws.

If a Claim is deemed to have not been submitted correctly the Participant will be notified via email and offered the opportunity to provide the missing information (which may include a photo of the relevant serial number of the Qualifying Product) to validate their Claim within seven (7) days. If no response is received, then the Claim shall be marked as invalid and the Participant will no longer be eligible to receive the Reward.

Presuming that the Claim has been submitted in accordance with these Terms and Conditions and confirmed as validated, the company which administers the Promotion on behalf of the Promoter ("Administrator") will endeavour to send the Reward to the Participant by email within fifteen (15) calendar days of validation.
