

# **Terms and Conditions**

Participants agree to be bound by these Terms and Conditions (the 'Terms and Conditions'). Any information or instructions published by the Promoter about the Promotion at <https://claim-nothing.co.uk/launch> form part of these Terms and Conditions.

## **The Promoter**

1. The Promoter is Nothing Technology Limited ("Nothing").

## **Promotion Period**

2. The Promotion will run for the applicable period as set out Table 1 below (the "Promotion Period").

## **Eligibility**

3. To be eligible to participate in the Promotion you must be an individual over the age of 18 ("Individual Participant") and lawfully resident in the United Kingdom only (including the Channel Islands and Isle of Man) (the "Territory"), or a company with an address and operating within the Territory ("Company Participant").
