This website and the Promotion are operated by The Marketing Lounge Partnership Limited ("MLP"), a company incorporated in England and Wales with registered number 6467245, whose registered office is at The Cow Shed, Walnut Tree Farm, Lower Stretton, Cheshire, WA4 4PG, the ("Operator"), on behalf of the Promoter. Operator is responsible for the administering the Promotion, notifying eligible customers and fulfilling the LatteCrema Cool upgrade Set ("Gift").

2. **Promotion Period:** The Promotion is valid while stocks last from 00:00 on 29th April 2026 to 23:59 on 24th June 2026 (inclusive) (the "**Promotion Period**").
