

Terms and Conditions

- The MSI “SELECT YOUR CARD” (“Event”) promotion starts from 17/10/2025 to 30/11/2025 (CET + 01:00), or until supply of redemption items last, whichever occurs first. Please consult the world clock for time zone conversion information.

Redemption.

1. To enter, You must complete the following steps:
 - i. Purchase one eligible MSI product from participating MSI partners listed on the promotion page, and register your product in MSI Member Center. You will need to create a MSI Member account at <https://account.msi.com/login> if You have not previously registered.
